ORDINANCE NO. 90-017

**AN ORDINANCE REGULATING THE VENDING AND/OR PEDDLING OF COOKED FOODS
IN THE CITY OF NAGA AND PROVIDING PENALTIES FOR VIOLATION THEREOF: -**

Be it ordained by the Sangguniang Panlungsod of the City of Naga, that:

SECTION 1. - TITLE OF ORDINANCE. - This ordinance shall be known as the
“Vending of Cooked Foods Ordinance”;

SECTION 2. - SCOPE OF ORDINANCE. - This ordinance shall cover the operation of
all vendors of cooked foods, whether by peddling around and/or, stationary in a counter/table at
a particular temporary location, sidewalks or vacant space that may be allowed or permitted by
the City mayor;

SECTION 3. - DEFINITION OF TERMS. . - As used in this ordinance:

- a) Vendors of cooked foods shall refer to any person, single proprietorship,
partnership, association, or company or their business representatives or agents
who conduct the business of selling or peddling cooked foods;
- b) Cooked goods shall refer to all kinds of foods and drinks that are cooked and/or
mixed, intended to be sold to the general public such as, but not limited to, rice,
viands, fried bananas, barbecue, log-log, lugaw, peanuts and peas, dinuguan,
gulaman, fruit juice, other ready mixed drinks, and the like; This will also include
sliced pineapple, pakwan and similar fruits peeled and sliced for sale.

SECTION 4. – The following shall be required of all vendors of cooked foods:

- a) For stationary Counter vending:
 - 1. The vendor shall secure health certificate annually from the City Health office;
 - 2. He shall secure the necessary business permit from the City Treasurer’s Office
annually. This business permit shall in no way be deemed an authority to sell
cooked foods permanently in a particular location as may be authorized by the
City mayor;
 - 3. Cooked foods on display must be properly covered so as to free them from dust,
flies, vermin and other contaminants;
 - 4. Cooked foods displayed for sale such as barbecue, fried bananas, sliced fruits
and the likes must be wrapped with sanitary wrappers;
 - 5. Ready mixed drinks should be placed in a container with faucet to avoid
contamination;

6. Those selling rice, viands and ready mixed drinks should provide 2 or 3 pails of water for washing purposes. Spoons and forks must be washed with soap and water and placed in boiling water before they are given for the next customer's use;
7. Each vending counter must be provided with own trash cans with cover and its premises must be clean and free from rubbish all the time;
8. The vending counter of cooked foods, whether table-like platform type and other of similar type must be provided with wheels for easy mobility;

b. For peddling Around Cooked foods:

1. The vendor shall secure health certificate annually from the City Health Office;
2. He shall secure the necessary business permit from the City Treasurer's office annually;
3. Cooked foods being peddled must be properly covered so as to free them from dust, flies, vermins and other contaminants;
4. Cooked foods, such as fried bananas, barbecue, camote cue and other similar nature of cooked foods must be wrapped with sanitary wrappers.

SECTION 5. - FOOD IN STATE OF DECOMPOSITION. - It shall be unlawful for any person to sell or offer for sale any cooked food that is in state of decomposition or that is contaminated, and adulterated, or that has been prohibited by the City Health Officer or by the police authorities;

SECTION 6. - The City Health Officer and the City sanitary Inspectors are hereby deputized to strictly implement this ordinance in coordination with the City INP;

SECTION 7. - PENALTY CLAUSE. - Any violation provisions of this ordinance shall be penalized with a fine of two Hundred (200.00) Pesos payable to the City Treasurer's Office, or an imprisonment of not more than three (3) months or both at the discretion of the court. Upon violation of any provision of this ordinance, the display counter or platform and other utensils and facilities shall be impounded at the Naga city INP Station to be used as evidences in the filling of the appropriate case in the court;

SECTION 8. - SEPARABILITY CLAUSE. - If any provision of this ordinance or the application thereof, to any person or circumstances is held invalid, the remainder of this ordinance and the application of such provision to other persons or circumstances shall not be affected thereby;

SECTION 9. - REPEALING/AMENDATORY CLAUSE. - All ordinances, rules and regulations or portion thereof, inconsistent to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 10. - EFFECTIVITY CLAUSE. - This ordinance shall take effect fifteen days upon its approval.
